•Each participant must supply their own grill- gas or charcoal, spices & rubs, sauces, ice chest, small work table plus their own meat for the competition.

•**Pork Ribs is the featured item.** Ribs may be spare ribs, St. Lois style cut or baby back ribs. The ribs must include the bone. Country style ribs are prohibited. A minimum of 6 pieces, must be turned in to the judges at your turn in time. Turn in rules will be handed out when you check in. Meat must be stored in original packaging at **40 degrees or less** and cannot be pre cooked or pre marinated. All meat will be inspected when you check in to assure temperature and quality control and fairness.

•Turn in time to the Judges will begin at 1:30pm Saturday, September 11th. When you check in, you will be assigned your time.

•One winner will be crowned the Amateur BBQ Rib King!

The winner will receive a 40" Flat Screen Mitsubishi Television valued at \$1700 from U.S. Tech!
